■ KEY INSIGHT

The chandelier strategy has proven effective (Win Rate: 47.1%, Avg Return: +5.7%), but patience is critical. Only enter on confirmed signals with proper risk management. Current technical confluence of 3 does not meet entry threshold of 5 - remain on sidelines. Fundamental backdrop shows 24% earnings growth with 71% institutional ownership, indicating strong conviction from professional investors.
